

Transitioning Transportation - Clean, Just, and Resilient



Based on 2017 data (see graphic from Dane County's Draft Climate Action Plan), the transportation sector accounts for 29% of emissions in Dane Co. Just electrifying vehicles won't solve many of the inequities and other negative impacts of our transportation system. It is vital that we work to get people into shared transportation or out of their cars.

What's possible in emission reductions from transportation

Key strategies for emission reductions beyond electrification can be found in the *Road to Clean Transportation*, a report looking at Wisconsin, Minnesota, Ohio, Michigan, South and North Dakota, Indiana, and Iowa.

- Smart Growth and Compact Development: Emissions Reduction Potential 5 to 16 percent by 2050.
- Public Transportation: Emissions Reduction Potential 0.9 to 3.6 percent by 2050.
- Active Transportation [walking, biking etc.]: Emissions Reduction Potential 0.4 to 1.1 percent by 2050.
- Shared Mobility [shared/multi-passenger options]: Emissions Reduction Potential 1 to 4 percent.
- Smart Pricing [ending subsidies of high-carbon transportation]: Emissions Reduction Potential 3.6 to 10.7 percent by 2050.

Other benefits/considerations*

- Shoring up and complementing emission reductions from other sectors like energy-efficient buildings and job centers.
- Connecting people to opportunities like jobs that are inaccessible to them due to income or mobility.
- Investing in multi-modal transportation systems that attract new businesses, return 3x the dollar invested, and advance recreation and tourism.
- Building a transportation system and land-use pattern that works for everyone to address equity and justice issues in our county by
 - o changing historic zoning policies that perpetuate racial segregation,
 - o linking affordable housing to jobs,
 - o relieving the financial burdens of a car culture for those who do not drive or do not own a car, and
 - o creating livable neighborhoods without the health burdens of traffic noise and air pollutants.
- Improving the health of a community and its members by promoting walking, biking and active transportation while reducing healthcare costs and improving air quality locally and regionally.
